Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Wisconsin Office of Energy Innovation to purchase and install photovoltaic (PV) solar systems at the Monona Grove High School. The 663 kW solar PV array would be installed on the roof of the high school in Monona, WI.

The proposed array would consist of 1598 solar modules and 10 inverters along with associated electrical wiring, conduit, racks, and ballasts. No structural improvements to the roof would be required. A ground mounted transformer on a pad would be replaced to meet new utility requirements. All work would be contained to the existing pad and would not require any ground disturbance. The PV system would be interconnected to the grid in the main electrical service area inside the school building.

The State of Wisconsin must adhere to the restrictions of their DOE executed Historic Preservation Programmatic Agreement with their State Historic Preservation Office for the proposed activities. Any changes to the project activities or locations are subject to additional NEPA review by DOE and are not authorized for Federal funding unless and until the Contracting Officer provides written authorization on those additions or modifications.
