Proposed Action Title: Los Alamos National Laboratory -- Advanced Manufacturing of Embedded Heat Pipe Nuclear Hybrid Reactor

Proposed Action Description:

AMENDED NEPA DETERMINATION: (See attached original Determination, dated February 6, 2019). This Amended Determination follows the approval of additional funds and schedule to support the project team's small-scale research and development of components for the PRIUS-NH, a Proliferation Resistant Innovative Ultra Safe Nuclear Hybrid reactor. Specifically, the project team will (1) conduct further testing on candidate materials for high-temperature heat pipe material, (2) identify and verify final material for use in high temperature pipes and other high-heat applications, (3) conduct final testing procedures, and (4) finalize reactor design. If successful, this project will advance technology for a scalable, compact, high-temperature, embedded heat pipe nuclear reactor designed to meet energy needs at remote locations and for integration into nuclear-renewable hybrid microgrids.

Project activities will be conducted at a existing facilities at Los Alamos National Laboratory (Los Alamos, NM) and Westinghouse Electric Company LLC (Pittsburgh, PA) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work

Proposed Action Title: Los Alamos National Laboratory - Advanced Manufacturing of Embedded Heat Pipe Nuclear Hybrid Reactor

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop components for the PRIUS-NH, a Proliferation Resistant Innovative Ultra Safe Nuclear Hybrid reactor. Specifically, the project team will (1) investigate and select advanced materials, (2) build and test a non-nuclear engineering demonstration unit of the reactor, (3) evaluate and demonstrate cost-effective advanced sensors, and (4) perform advanced simulations of the reactor design. If successful, this project will advance technology for a scalable, compact, high-temperature, embedded heat pipe nuclear reactor designed to meet energy needs at remote locations and for integration into nuclear-renewable hybrid microgrids.

Project activities will be conducted at existing facilities at Los Alamos National Laboratory (Los Alamos, NM), Westinghouse Electric Company (Cranberry, PA), Idaho National Laboratory (Idaho Falls, ID), and University of Pittsburgh (Pittsburgh, PA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work. LANL, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work involving radiological materials before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.
