Proposed Action Title: Deer Feeder Study

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

SREL will install deer feeders and game cameras at selected locations, beginning in summer 2022. Baiting for white-tailed deer is extensively used throughout many southeastern US states, although wild pigs may exclude or outcompete white-tailed deer (*Odocoileus virginianus*) from bait locations. Access to energy rich deer food may contribute to increased reproduction in wild pigs thus contributing to the continued growth of wild pig populations. This study will quantify interactions between white-tailed deer and wild pigs at bait stations.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
