

Proposed Action Title: Design and Install a New Seismically Qualified Cubicle for MCC-C Cubicle 3A (HS-245019-ELNH-MCC-C-EEC-3A)

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The H-Canyon Central Exhaust Fan #3 breaker failed and damaged the entire cubicle (HS-254019-ELNH-MCC-C-EEC-3A). This cubicle needs to be replaced. An exact replacement of this cubicle is not available due to the age of the equipment and some of the internal components of this cubicle are discontinued. The existing cubicle is seismically qualified and is functionally classified as Safety Significant (SS). The replacement cubicle should also be Seismically Qualified and will be functionally classified as SS. This replacement should be equivalent to the current cubicle specification and also be acceptable as a spare for the other two Central Exhaust Fan cubicles (HS-254019-ELNH-MCC-A-EEC-2A and HS-254019-ELNH-MCC-B-EEC-2A) in case of catastrophic failure.
