Proposed Action Title: Kent Houston Offshore Engineering -- Passively Controlled Floating Wind Platforms for Low-Cost Energy

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Houston, Texas; Boulder, Colorado; Huntsville, Alabama; College Station, Texas

Proposed Action Description:

Funding will support the project team's research and development of two floating offshore wind turbine technologies, integrated with NASA-developed passive control systems to mitigate platform dynamics. Specifically, the project team will (1) design two model prototypes- one for deep and one for shallow water, and (2) conduct thorough laboratory testing of prototypes to ensure strength and function in open ocean conditions. If successful, this project will result in a reduced cost floating wind turbine system, ultimately reducing cost of electricity with low to no greenhouse gas emissions and reducing fossil fuel combustion.

Project activities will be conducted at existing facilities at Kent Houston Offshore Engineering (Houston, TX), National Renewable Energy Laboratory (Boulder, CO), National Aeronautics and Space Administration (Huntsville, AL), LINC Research Inc. (Huntsville, AL) Texas A&M University Wind Tunnel (College Station, TX) and American Bureau of Shipping (Houston, TX) designed for the applicable activities. The project team has certified that (a) project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements, and (b) no modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
