(a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy Actions to efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of conserve potentially harmful substances. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Clemson University to expand the Clemson BikeShare network. Under this project, a concrete pad would be designed and installed along with bike share docks and bicycles, all of which would be located on the grass median between two park-n-ride facilities. The concrete pad would be approximately 32 feet by 4 feet and 6 inches deep.

The docks would arrive fully assembled and would be bolted onto the concrete pad. Programming of the docks would occur on site. The bikes would be battery powered and, when necessary, recharged at the maintenance contractor's shop and transported back to campus. As such, there would be no power connections at the docking station. Bikes would be assembled and safety checked in Greenville, SC before being deployed at the docks. This would be the eighth station in the Clemson BikeShare network and would add 12 bike share docks and 6 electric assist bikes to the existing fleet of 24 e-bikes and 23 acoustic bikes.

DOE has considered potential impacts on resources of concern, including those of ecological, historical, cultural, and socioeconomic nature. Based on the proposed project activities and the location of the project site on a median between two parking lots, DOE does not anticipate adverse impacts on these resources.

Any changes to the project activities or locations are subject to additional NEPA review by DOE and are not authorized for federal funding unless and until the Contracting Officer provides written authorization on those additions or modifications.
