## EAGLE LNG PARTNERS JACKSONVILLE II LLC DOCKET NO. 22-168-LNG

**PROPOSED ACTION DESCRIPTION:** Eagle LNG Partners Jacksonville II LLC (Eagle Maxville) filed an application (Application) with the Office of Fossil Energy and Carbon Management (FECM) on December 29, 2022, pursuant to section 3 of the Natural Gas Act (NGA)<sup>1</sup> and 10 CFR Part 590 of the Department of Energy's (DOE) regulations.

In relevant part, Eagle Maxville states that its proposed exports qualify as "small-scale natural gas exports" under DOE's regulations at 10 CFR §§ 590.102(p) and 590.208(a). Specifically, Eagle Maxville seeks long-term authorization to export domestically produced liquefied natural gas (LNG) in a volume equivalent to 51.75 billion cubic feet per year (Bcf/yr) of natural gas (0.14 Bcf per day). Eagle Maxville requests that the export term extend through December 31, 2050. Eagle Maxville requests authority to export the LNG to any country with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries).<sup>2</sup>

Eagle Maxville intends to source LNG from its currently-operational Maxville Facility and from third-party LNG production facilities, to load the LNG into approved International Organization for Standardization (ISO) containers and transport it by truck and/or in highway trailers approved by the U.S. Department of Transportation to ports capable of handling ISO containers, and then to load the containers onto ocean-going vessels, including container ships or roll-on/roll-off oceangoing carriers, for export. In Appendix C to its Application, Eagle Maxville identifies 13 facilities from which it may source LNG for export.

DOE's proposed action is to authorize the exports described in the Application as small-scale natural gas exports.
