Dear Mr. Anderson:

On June 6, 2014, the U.S. Department of Energy ("DOE"), Office of Fossil Energy ("DOE/FE") issued DOE/FE Order No. 3442 granting Cheniere Marketing, LLC ("CMI") blanket authorization to export liquefied natural gas ("LNG") previously imported into the United States from foreign sources, on its own behalf and as agent for others who hold title at the time of export, after registering those entities with DOE/FE. Pursuant to the registration requirements outlined in DOE/FE Order No. 3442, CMI and Sabine Pass Liquefaction, LLC ("SPL") submit the following registration information so that CMI may act as agent for SPL.

- a. Pursuant to Ordering Paragraphs C and E, SPL acknowledges and agrees to include the following provision in any contract for the sale or transfer of LNG exported pursuant to DOE/FE Order No. 3442:


Customer or purchaser acknowledges and agrees that it will resell or transfer LNG purchased hereunder for the delivery only to countries with the capacity to import ocean-going LNG carriers and with which trade is not prohibited by U.S. law or policy, and/or to purchasers that have agreed in writing to limit their direct or indirect resale or transfer of such LNG to such countries. Customer or purchaser further commits to cause a report to be provided to Cheniere Marketing, LLC that identifies the country of destination, upon delivery, into which the exported LNG was actually delivered, and to include in any resale contract for such LNG the necessary conditions to ensure that Cheniere Marketing, LLC is made aware of all such actual destination countries.

- b. Pursuant to Ordering Paragraph E, SPL acknowledges and agrees to provide CMI with all information and copies of contracts necessary in order to **permit CMI to** register ~~SPL~~ with DOE/FE and further provides as follows:

- i. SPL agrees to comply with DOE/FE Order No. 3442 and all applicable requirements of DOE's regulations at 10 C.F.R. Part 590, including but not limited to destination restrictions.
- ii. SPL's exact legal name is Sabine Pass Liquefaction, LLC and its principal office is located at 700 Milam Street, Suite 1900, Houston, TX 77002. SPL is a limited liability company organized under the laws of Delaware, and is a wholly-owned indirect subsidiary of Cheniere Energy Partners, L.P., a publicly-traded Delaware limited partnership that is, in turn, an indirect subsidiary of Cheniere Energy, Inc., a publicly-traded corporation.
