ORDER GRANTING LONG-TERM AUTHORIZATION
TO EXPORT LIQUEFIED NATURAL GAS TO FREE TRADE AGREEMENT NATIONS,
FOR SMALL-SCALE EXPORTS OF LIQUEFIED NATURAL GAS, AND
VACATING PRIOR AUTHORIZATION

DOE/FECM ORDER NOS. 4975 AND 4078-B

MARCH 12, 2023

### I. INTRODUCTION

On December 29, 2022, Eagle LNG Partners Jacksonville II LLC (Eagle Maxville) filed an Application<sup>1</sup> with the Department of Energy's (DOE) Office of Fossil Energy and Carbon Management (formerly the Office of Fossil Energy)<sup>2</sup> under Section 3 of the Natural Gas Act (NGA),<sup>3</sup> requesting long-term, multi-contract authorization<sup>4</sup> to export domestically produced liquefied natural gas (LNG). Eagle Maxville requests authorization to export LNG as follows:

- (i) Under section 3(c) of the NGA, to any country with which the United States has, or in the future may enter into, a free trade agreement (FTA) requiring national treatment for trade in natural gas (FTA countries),<sup>5</sup> and
- (ii) Under section 3(a) of the NGA, to any country with which trade is not prohibited by United States law or policy (non-FTA countries).<sup>6</sup>

Eagle Maxville states that its proposed non-FTA exports qualify as "small-scale natural gas exports" under DOE's regulations at 10 C.F.R. §§ 590.102(p) and 590.208(a), and therefore should be deemed to be consistent with the public interest under NGA section 3(a).<sup>7</sup>

Eagle Maxville seeks to export LNG in a total volume equivalent to 51.75 billion cubic feet (Bcf) per year (Bcf/yr), or 0.14 Bcf per day (Bcf/d), of natural gas. Eagle Maxville states that it intends to "load LNG destined for export into approved [International Organization for Standardization (ISO)] containers at its currently-operational Maxville Facility and after loading, will transport the containers by truck and load the containers onto container ships or roll-on/rolloff oceangoing carriers for export at the nearby Port of Jacksonville or other ports capable of handling ISO containers." Additionally, Eagle Maxville states that it "expects from time to time to procure LNG produced by third parties . . . in any one of several existing LNG production facilities located in Florida, Alabama, Georgia, Texas, Louisiana, Pennsylvania, Washington, and California."<sup>10</sup> Eagle Maxville further states that it "anticipates purchasing LNG produced in these facilities and taking delivery of this LNG in ISO containers leased by Eagle Maxville for transfer to the point of export,"11 and that "[a]ny LNG Eagle Maxville purchase[d] from third party suppliers [would] be transported by road using Department of Transportation-approved highway trailers and [would] be transferred to ocean-going vessels in ISO containers."12 Specifically, in Appendix C to the Application, Eagle Maxville identifies 13 facilities in the United States from which it seeks to source LNG for export (collectively, the Facilities), as well as their associated ports of export. 13

Eagle Maxville requests that its long-term authorization commence on the date of an order granting such authorization and extend through December 31, 2050. <sup>14</sup> Additionally, Eagle

Maxville requests authority to export the LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export.<sup>15</sup>

As Eagle Maxville has requested a single consolidated authorization, it has also asked that its existing authorization in DOE/FE Order Nos. 4078 and 4078-A be vacated and replaced concurrently with the consolidated authorization. <sup>16</sup>

In this consolidated Order, DOE grants Eagle Maxville's Application and authorizes the requested export volume of 51.75 Bcf/yr (0.14 Bcf/d) to both FTA and non-FTA countries on a non-additive basis. Specifically, DOE finds that the FTA portion of the Application falls within NGA section 3(c), and we therefore grant the requested FTA authorization without modification or delay.<sup>17</sup> DOE also finds that the proposed non-FTA exports qualify as "small-scale natural gas exports" under the criteria set forth in 10 C.F.R. § 590.102(p). Accordingly, we grant the small-scale portion of the Application under 10 C.F.R. § 590.208(a).

This Order, however, does not provide Eagle Maxville with an independent right to purchase or load LNG at any of the Facilities. DOE takes no position on the commercial arrangements that may be necessary for Eagle Maxville to effectuate the export of LNG approved in this Order.

#### II. BACKGROUND

Applicant. Eagle Maxville is a Delaware limited liability company with its principal place of business in The Woodlands, Texas. Eagle Maxville states that it "is a wholly-owned subsidiary of Eagle LNG Partners LLC, which also is a Delaware limited liability company, and an affiliate of Eagle LNG Partners Jacksonville LLC." <sup>18</sup>

<u>Liquefaction Facilities and Transport</u>. Eagle Maxville states that, under its current authorization, it produces the LNG it exports in a "small-scale LNG production facility located in west Jacksonville, Florida, which [it] constructed and now operates (the "Maxville Facility")." Eagle Maxville states that it now seeks "to increase the quantities of natural gas it may export in the form of LNG and to expand its authorization so that it may export LNG produced not only in the Maxville Facility but in third party facilities." <sup>20</sup>

Specifically, Eagle Maxville states that it intends to "load LNG destined for export into approved ISO containers at its currently-operational Maxville Facility," and also "anticipates purchasing LNG produced in [third-party] facilities and taking delivery of this LNG in ISO containers leased by Eagle Maxville for transfer to the point of export." In its Application, Eagle Maxville identifies 13 facilities in the United States for export purposes. 23

Eagle Maxville states that it intends to transport the LNG "in ISO containers by truck to commercial ports, where it will be loaded through existing facilities onto ocean-going vessels." Eagle Maxville adds that it intends to export "small volumes of LNG in approved ISO IMO7/TVAC-ASME LNG ('ISO") containers to various countries, primarily in the Caribbean." <sup>25</sup>

<u>Source of Supply.</u> Eagle Maxville states that its Maxville Facility, through a pipeline connected to the Southern Natural Gas Company, LLC pipeline system, "has direct access to major sources of natural gas supply, including supplies produced in the Gulf Coast region, both onshore and offshore," as well as "indirect access to additional sources of natural gas supply,

including sources located in the mid-continent region and in the Appalachian region, such as the Marcellus and Utica shale plays."<sup>26</sup> Eagle Maxville adds that it "expects that [its] third-party LNG suppliers [would] acquire natural gas from sources of natural gas supply located throughout the United States and delivered to the relevant LNG production facilities through the integrated natural gas pipeline grid."<sup>27</sup>

**Business Model.** Eagle Maxville requests authorization to export LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export.<sup>28</sup> Eagle Maxville states that it will file, or cause to be filed, all long-term commercial agreements, once executed, in accordance with DOE's established policy, and will comply with all DOE requirements for exporters and agents, including registration requirements.<sup>29</sup>

### III. STANDARD OF REVIEW

### A. FTA Authorization

Section 3(c) of the NGA was amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). In relevant part, applications to export natural gas, including LNG, to countries with which there is an FTA in effect requiring national treatment for trade in natural gas "shall be deemed to be consistent with the public interest" and granted "without modification or delay."<sup>30</sup>

### **B.** Small-Scale Authorization

DOE defines a "small-scale natural gas export" as an export of natural gas, including LNG, to a non-FTA country that meets the following two criteria:

(1) The application proposes to export natural gas in a volume up to and including

- 51.75 billion cubic feet per year, and
- (2) DOE's approval of the application does not require an environmental impact statement (EIS) or an environmental assessment (EA) under the National Environmental Policy Act, 42 U.S.C. 4321 *et seq.*<sup>31</sup>

Small-scale natural gas exports are deemed to be consistent with the public interest under NGA section 3(a).<sup>32</sup> Therefore, DOE will issue an export authorization upon receipt of a complete application to conduct small-scale natural gas exports.<sup>33</sup>

### IV. DISCUSSION AND CONCLUSIONS

#### A. FTA Authorization

We find that the FTA portion of Eagle Maxville's Application falls within NGA section 3(c), and therefore we grant the requested FTA authorization without modification or delay.<sup>34</sup>

### **B.** Small-Scale Authorization

We find that the non-FTA portion of the Application meets the criteria for small-scale natural gas exports, set forth in 10 C.F.R. § 590.102(p). First, Eagle Maxville requests authority to export LNG to non-FTA countries in a volume equivalent to 51.75 Bcf/yr of natural gas, which is consistent with the limit in the regulation. Second, DOE's National Environmental Policy Act (NEPA) procedures provide for a categorical exclusion if neither an EIS nor an EA is required—specifically, categorical exclusion B5.7 (10 C.F.R. Part 1021, Subpart D, Appendix B5), *Export of natural gas and associated transportation by marine vessel*. On March 8, 2023, DOE issued a categorical exclusion for the non-FTA portion of Eagle Maxville's Application

under this provision.<sup>36</sup> Accordingly, pursuant to 10 C.F.R. § 590.208(a), the proposed small-scale exports are deemed to be consistent with the public interest under NGA section 3(a), and DOE grants the requested authorization.

### V. FINDINGS

Based on the findings and conclusions herein, DOE grants the Application subject to the Terms and Conditions and Ordering Paragraphs set forth below.

# VI. TERMS AND CONDITIONS

#### A. Term of the Authorization

Consistent with DOE's practice, Eagle Maxville requests that its FTA and small-scale non-FTA authorizations commence on the date of an order granting such authorizations and extend through December 31, 2050.<sup>37</sup> Accordingly, the term for this authorization will commence on the date this Order is issued and extend through December 31, 2050.

## **B.** Commencement of Operations for Small-Scale Authorization

DOE will add as a condition of the small-scale authorization that Eagle Maxville must commence commercial LNG export operations no later than two years from the date of issuance of this Order. Because this Order allows for exports to begin from existing facilities, we find that Eagle Maxville should be able to commence small-scale exports of LNG immediately.

#### C. FTA Countries for FTA Authorization

The countries with which the United States has a FTA requiring national treatment for trade in natural gas are currently: Australia, Bahrain, Canada, Chile, Colombia, Dominican Republic, El Salvador, Guatemala, Honduras, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Republic of Korea, and Singapore.

# D. Transfer, Assignment, or Change in Control

DOE's natural gas regulations prohibit authorization holders from transferring or assigning authorizations to import or export natural gas without specific authorization by the Assistant Secretary for Fossil Energy and Carbon Management.<sup>38</sup> DOE has found that this requirement applies to any change in control of the authorization holder. This condition was deemed necessary to ensure that DOE will be given an adequate opportunity to assess the public interest impacts of such a transfer or change.

DOE construes a change in control to mean a change, directly or indirectly, of the power to direct the management or policies of an entity, whether such power is exercised through one or more intermediary companies or pursuant to an agreement, written or oral, and whether such power is established through ownership or voting of securities, or common directors, officers, or stockholders, or voting trusts, holding trusts, or debt holdings, or contract, or any other direct or indirect means.<sup>39</sup> A rebuttable presumption that control exists will arise from the ownership or the power to vote, directly or indirectly, 10% or more of the voting securities of such entity.<sup>40</sup>

# E. Agency Rights

Eagle Maxville requests authorization to export LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export. DOE previously has determined that, in LNG export orders in which Agency Rights have been granted, DOE shall require registration materials filed for, or by, an LNG title-holder (Registrant) to include the same

company identification information and long-term contract information of the Registrant as if the Registrant had filed an application to export LNG on its own behalf.<sup>41</sup>

To ensure that the public interest is served, this authorization shall be conditioned to require that where Eagle Maxville proposes to export LNG as agent for other entities that hold title to the LNG (Registrants), it must register with DOE those entities on whose behalf it will export LNG in accordance with the procedures and requirements described herein.

## F. Contract Provisions for the Sale or Transfer of LNG to be Exported

DOE will require that Eagle Maxville file or cause to be filed with DOE any relevant long-term commercial agreements associated with the export of LNG, including agreements pursuant to which Eagle Maxville intends to export LNG as agent for a Registrant. DOE finds that the submission of all such agreements or contracts within 30 days of their execution using the procedures described below will be consistent with the "to the extent practicable" requirement of section 590.202(b) of DOE's regulations.<sup>42</sup>

In addition, DOE finds that section 590.202(c) of DOE's regulations<sup>43</sup> requires that Eagle Maxville file, or cause to be filed, all long-term contracts associated with the long-term supply of natural gas to the Facilities, whether signed by Eagle Maxville or the Registrant, within 30 days of their execution.

DOE recognizes that some information in Eagle Maxville's or a Registrant's long-term commercial agreements associated with the export of LNG, and/or long-term contracts

associated with the long-term supply of natural gas to the Facilities, may be commercially sensitive. DOE therefore will provide Eagle Maxville the option to file or cause to be filed either unredacted contracts, or in the alternative (A) Eagle Maxville may file, or cause to be filed, long-term contracts under seal, but it also will file either: (i) a copy of each long-term contract with commercially sensitive information redacted, or (ii) a summary of all major provisions of the contract(s) including, but not limited to, the parties to each contract, contract term, quantity, any take or pay or equivalent provisions/conditions, destinations, re-sale provisions, and other relevant provisions; and (B) the filing must demonstrate why the redacted information or non-disclosed information should be exempted from public disclosure.<sup>44</sup>

To ensure that DOE destination and reporting requirements included in this Order are conveyed to subsequent title holders, DOE will include as a condition of this authorization that future contracts for the sale or transfer of LNG exported pursuant to this Order shall include an acknowledgement of these requirements.

# G. Export Quantity

This Order grants Eagle Maxville's Application in the full volume of LNG requested, up to the equivalent of 51.75 Bcf/yr of natural gas for FTA and non-FTA countries.

# **H.** Non-Additive Export Volumes

Consistent with DOE's small-scale export regulations, Eagle Maxville may not treat the FTA and small-scale non-FTA volumes in this Order as additive to one another.

#### VII. ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. Eagle LNG Partners Jacksonville II LLC (Eagle Maxville) is authorized by DOE to export domestically produced LNG obtained from any of the 13 Facilities listed in Appendix C of the Application. Eagle Maxville is authorized to export this LNG in approved ISO containers on vessels in a volume equivalent to 51.75 Bcf/yr of natural gas. The FTA and small-scale authorizations will commence on the date of this Order and extend through December 31, 2050. Eagle Maxville is authorized to export this LNG on its own behalf and as agent for other entities that hold title to the natural gas, pursuant to one or more contracts of any duration. 46

B. This Order does not give Eagle Maxville an independent right to purchase or load LNG from any of the identified Facilities. Eagle Maxville and each Facility may agree upon contractual terms for Eagle Maxville's export services, as they deem appropriate. Additionally, this Order does not restrict, through volume limitations or otherwise, any existing or future authorizations issued by DOE for any of the Facilities.<sup>47</sup>

C. Exports of LNG under this Order may be exported by vessel to any country with the capacity to import LNG, and with which trade is not prohibited by U.S. law or policy.

D. For the authorization to non-FTA countries under the Small-Scale Rule, Eagle

Maxville must commence export operations using the Facilities no later than two years from the

date of issuance of this Order.

E. Eagle Maxville shall ensure that all transactions authorized by this Order are permitted and lawful under U.S. laws and policies, including the rules, regulations, orders,

policies, and other determinations of the Office of Foreign Assets Control of the U.S.

Department of the Treasury, the Federal Energy Regulatory Commission, and the Pipeline and Hazardous Materials Safety Administration of the U.S. Department of Transportation, as applicable. Failure to comply with these requirements could result in rescission of this authorization and/or other civil or criminal penalties.

- F. (i) Eagle Maxville shall file, or cause others to file, with the Office of Regulation, Analysis, and Engagement an unredacted copy of <u>all executed long-term contracts associated</u> with the long-term export of LNG. The unredacted copies must be filed within 30 days of their execution and may be filed under seal, as described above.
- (ii) Eagle Maxville shall file, or cause others to file, with the Office of Regulation, Analysis, and Engagement a non-redacted copy of <u>all executed long-term contracts associated</u> with the long-term supply of natural gas to the Facilities. The unredacted copies must be filed within 30 days of their execution and may be filed under seal, as described above.
- G. Eagle Maxville is permitted to use its authorization to export LNG as agent for other LNG title-holders (Registrants), after registering those entities with DOE. Registration materials shall include an agreement by the Registrant to supply Eagle Maxville with all information necessary to permit Eagle Maxville to register that person or entity with DOE, including: (1) the Registrant's agreement to comply with this Order and all applicable requirements of DOE's regulations at 10 C.F.R. Part 590, including but not limited to destination restrictions; (2) the exact legal name of the Registrant, state/location of incorporation/registration, primary place of business, the Registrant's ownership structure, including the ultimate parent entity if the Registrant is a subsidiary or affiliate of another entity; (3) the name, title, mailing address, e-mail address, and telephone number of a corporate officer or employee of the Registrant to whom

inquiries may be directed; and (4) within 30 days of execution, a copy of any long-term contracts not previously filed with DOE, described in Ordering Paragraph F of this Order.

Any change in the registration materials—including changes in company name, contact information, length of the long-term contract, termination of the long-term contract, or other relevant modifications—shall be filed with DOE within 30 days of such change(s).

H. Eagle Maxville, or others for whom Eagle Maxville acts as agent, shall include the following provision in any agreement or other contract for the sale or transfer of LNG pursuant to this Order:

Customer or purchaser acknowledges and agrees that it will resell or transfer LNG, purchased hereunder for delivery only to countries identified in Ordering Paragraph C of DOE/FECM Order No. 4975, issued March 12, 2023, in Docket No. 22-168-LNG, and/or to purchasers that have agreed in writing to limit their direct or indirect resale or transfer of such LNG to such countries. Customer or purchaser further commits to cause a report to be provided to Eagle LNG Partners Jacksonville II LLC that identifies the country (or countries) into which the LNG was actually delivered, and to include in any resale contract for such LNG the necessary conditions to ensure that Eagle LNG Partners Jacksonville II LLC is made aware of all such actual destination countries.

- I. Within two weeks after the first export authorized in Ordering Paragraph A occurs, Eagle Maxville shall provide DOE written notification of the date on which the first export occurred.
- J. With respect to any change in control of the authorization holder, Eagle Maxville must comply with DOE's Procedures for Change in Control Affecting Applications and Authorizations to Import or Export Natural Gas.<sup>48</sup>
- K. Monthly Reports: With respect to the exports authorized by this Order, Eagle Maxville shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report on Form FE-746R indicating whether

exports of LNG have been made. The first monthly report required by this Order is due not later than the 30<sup>th</sup> day of the month following the month of first export. In subsequent months, if exports have not occurred, a report of "no activity" for that month must be filed. If exports have occurred, the report must provide the information specified for each applicable activity and mode of transportation, as set forth in the Guidelines for Filing Monthly Reports. M. Eagle Maxville's authorization to export LNG by vessel via approved ISO containers, granted in DOE/FE Order No. 4078 on September 15, 2017, and as amended by DOE/FE Order No. 4078-A on December 30, 2020, is hereby vacated, effective March 12, 2023. Issued in Washington, D.C., on March 12, 2023.
