

Proposed Action Title: K-51 Alarm Scheme Update for 233-H Tritium Air Monitoring System

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The facility is preparing for the upcoming implementation of the Combined Tritium Facility (CTF) Safety Basis (SB). As part of this CTF, Kanne K-51 will be elevated to LCO 3.3.2 related equipment. Kanne K-51 is presently configured to allow the system to cycle through various sample points in the HANM Environmental Condition (EC) area including corridor sample point outside of the EC area for monitoring sample air. CTF SB proposal is to credit just one process area sample point on Kanne K-51. The credited process area sample point, in its present configuration, will not be monitored should the alarm be locked in on the corridor sample point. A change to the alarm schematic must be made to support this effort.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
