

Proposed Action Title: 786-5A Trailer, Make Repairs as Needed

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The 786-5A Trailer is an older structure (Occupied) and needs all the windows repaired from water intrusion by leaking windows. Additional building repairs as needed.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
