

Proposed Action Title: Replacement of Building 233-H Doors 301/08

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Building 233-H Doors 301/08 are old and heavy, and their hinges require frequent maintenance. Additionally, based on the current security requirements these types of doors are no longer needed and can be replaced with lighter weight doors. The Tritium facility would like to procure and install a new set of doors to replace door 301/08.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
