

Proposed Action Title: Sample Cutting of Radioactive Samples for Metallographic Examination

Proposed Action Description:

Create Ingots containing uranium and/or thorium alloyed with stainless steel with small amounts of yttrium oxide created in D-0142 under the Environmental Evaluation Checklist (EEC) "TC-A-2012-0009 rev. 11" will be sectioned using a saw in D-0179 for analysis.
