

Proposed Action Title: Load Center B4 Outage

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Proposed activity will cover the various Temporary Modifications associated with the B4 Outage. Load Center (LC) B4 will be de-energized to perform scheduled preventative maintenance.
