

Proposed Action Title: SRS Field Sampling for Rad and Non-rad Environmental Media

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC will only cover the collection of samples and the analysis of samples that will be analyzed at SRNL as well as the transport of the stored samples off site. Samples will be shipped off site to ORNL or be processed in our non-rad lab setting at SRNL. Additionally, an AquaTroll water quality sensor will be calibrated and used to measure water quality parameters at various sampling locations.
