ORDER GRANTING REQUEST TO AMEND AUTHORIZATION  
TO IMPORT AND EXPORT NATURAL GAS FROM AND TO CANADA  
TO REFLECT CORPORATE NAME CHANGE

DOE/FECM ORDER NO. 4739-A

APRIL 12, 2023

On September 13, 2021, the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) issued DOE/FECM Order No. 4739 (Docket No. 21-91-NG), under section 3 of the Natural Gas Act (NGA).<sup>1</sup> That order granted the entity known at the time as Marathon Power LLC (Marathon Power) authorization to import and export a combined total volume of 2 billion cubic feet of natural gas from and to Canada by pipeline, for a two-year term that began on October 2, 2021, and extends through October 1, 2023.

On January 17, 2023, DOE was notified that Marathon Power's corporate name had been changed to "Energo Power & Gas LLC" (Energo Power & Gas).<sup>2</sup> The corporate name change took effect December 13, 2022.<sup>3</sup> In light of the name change, Energo Power & Gas requests that DOE amend its authorization in Docket No. 21-91-NG.<sup>4</sup>

DOE finds that Energo Power & Gas' request to amend the specified authorization to reflect its corporate name change is consistent with the public interest, pursuant to NGA section 3.

### **ORDER**

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. The name of the authorization holder of DOE/FECM Order No. 4739 is amended to Energo Power & Gas LLC.
