## To: People interested in the Klickitat Hatchery Spring Chinook Upgrades Project

Bonneville Power Administration (BPA) has prepared a draft environmental assessment (EA) for the proposed Klickitat Hatchery Spring Chinook Upgrades Project. The EA describes the project and why it is needed, discusses the environmental impacts the project would create, and lists the mitigation measures that would lessen those impacts. This letter requests your comments on the EA, announces a public meeting, and outlines the next steps for the project.
