Long-Term Supply Contracts**

Dear Ms. Sweeney:

DOE/FE has issued long-term orders under Section 3 of the Natural Gas Act authorizing Sabine Pass Liquefaction, LLC ("SPL") to export liquefied natural gas ("LNG") from the Sabine Pass LNG Terminal both to nations with which the United States has a free trade agreement requiring the national treatment for trade in natural gas and LNG ("FTA Nations") and to nations with which the United States has no such agreement ("Non-FTA Nations"). Specifically, DOE/FE has issued orders collectively authorizing LNG exports from the Sabine Pass LNG Terminal to FTA Nations in an amount of up to the equivalent of approximately 4.14 Bcf/d of natural gas in FE Docket Nos. 10-85-LNG, 13-30-LNG, 13-42-LNG, 13-121-LNG, and 14-92-LNG; and it has issued orders collectively authorizing LNG exports from the Sabine Pass LNG Terminal to Non-FTA Nations in an amount of up to the equivalent of approximately 4.14 Bcf/d of natural gas in FE Docket Nos. 10-111-LNG, 13-30-LNG, 13-42-LNG, 13-121-LNG and 15-63-LNG.<sup>1</sup>

In DOE/FE Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, and 3792, DOE/FE directed SPL to file with DOE/FE's Office of Natural Gas Regulatory Activities "all executed long-term contracts associated with the long-term supply of natural gas"<sup>2</sup> to the Sabine Pass LNG Terminal. Additionally, DOE/FE has stated that it "recognizes that some information in . . . long-term contracts associated with the long-term supply of natural gas to the Sabine Pass LNG Terminal may be commercially sensitive."<sup>3</sup> In this regard, DOE/FE has given SPL the option to file long-term contracts under seal along with a public summary of the major provisions of the contracts.<sup>4</sup>

SPL has entered into North American Energy Standards Board ("NAESB") Base Contracts for Sale and Purchase of Natural Gas ("Base Contracts") with each of the following sellers:

Pursuant to the terms of each of the NAESB Base Contracts, the associated Transaction Confirmations (“Confirmations”) document transactions whereby each of the sellers, respectively, agree to sell to SPL a fixed quantity of natural gas on a firm, long-term basis. SPL intends to liquefy the natural gas secured under the Confirmations for export from the Sabine Pass LNG Terminal, pursuant to the authorizations granted in the above-referenced proceedings.

The NAESB Base Contracts and Confirmations contain commercially sensitive information, and are being filed under seal.<sup>5</sup> SPL respectfully requests that the NAESB Base Contracts and Confirmations be granted confidential treatment. A summary of the major provisions that are not deemed confidential is set forth in Appendix A hereto.
