Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC (“Sabine Pass”) hereby submits¹ for filing under seal, a non-redacted copy of the Novation and Amendment Agreement, dated May 22, 2019, between Cheniere Marketing, LLC (“Cheniere Marketing”), Sabine Pass and Vitol Inc. (“Vitol”), among others (the “Novation and Amendment Agreement”). The Novation and Amendment Agreement assigns to Sabine Pass the previously submitted long-term sale and purchase agreement (“SPA”) entered into by Cheniere Marketing and Vitol on September 14, 2018. The Novation and Amendment Agreement contains certain conditions to its effectiveness.

Sabine Pass is also filing herewith a public summary of the major provisions of the SPA, as assigned and amended by the Novation and Amendment Agreement. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy (“DOE/FE”) Order Nos. 2833, 2961-A, 3306, as amended by 3306-A, 3307, as amended by 3307-A, 3384, as amended by 3384-A, 3595, 3669, as amended by 3669-B, & 3792.² Sabine Pass hereby requests
