Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the amended and restated long-term sale and purchase agreement (the "SPA") entered into by Cheniere Marketing International LLP ("CMI") on July 15, 2021 with NFE North Trading LLC ("NFE") for the long-term sale and export of liquefied natural gas ("LNG") from the Sabine Pass LNG Terminal. The SPA amends and restates the long-term sale and purchase agreement originally entered into by CMI and NFE North Trading Limited on December 20, 2020. Under the SPA, LNG may also be delivered by CMI to NFE from other sources, including from the Corpus Christi Liquefaction Project.²

In addition, Sabine Pass was notified on July 26, 2021 that NFE North Trading Limited (the original counterparty to the agreement entered into by CMI on December 20, 2020) re-domiciled to Delaware, effective June 16, 2021. As a result of this re-domiciling, NFE North Trading Limited changed its name to NFE North Trading LLC.

Sabine Pass is also filing herewith a public summary of the major provisions of the SPA. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy ("DOE/FE") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, and 4520 (each as may have been amended).³

The SPA is being sent to DOE/FE by overnight mail.

The SPA is also being filed contemporaneously under DOE/FE Docket Nos. 12-97-LNG, 12-99-LNG, & 19-124-LNG.
