Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the long-term sale and purchase agreement (the "SPA") entered into by Cheniere Marketing, LLC ("Cheniere Marketing") on November 4, 2021 with Sinochem Group Co., Ltd ("Sinochem") for the long-term sale and export of liquefied natural gas ("LNG") from the Sabine Pass LNG Terminal. Under the SPA, LNG may also be delivered by Cheniere Marketing to Sinochem from other sources, including from the Corpus Christi Liquefaction Project.²

Sabine Pass is also filing herewith a public summary of the major provisions of the SPA. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy ("DOE/FE") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, and 4520 (each as may have been amended).³

Major Provisions Summary**

**LNG SALE AND PURCHASE AGREEMENT (FOB), DATED NOVEMBER 4, 2021,
BETWEEN CHENIERE MARKETING, LLC AND SINOCHEM GROUP CO., LTD⁴**

1. DOE Order/FE Docket No(s):

FE Docket Nos. 10-85-LNG, 10-111-LNG, 13-30-LNG, 13-42-LNG, 13-121-LNG, 14-92-LNG, 15-63-LNG, & 19-125-LNG

2. LNG Liquefaction/Export Facility and Location:

LNG may be delivered by Seller to Buyer at the Sabine Pass LNG Terminal located in Cameron Parish, Louisiana or at any number of liquefaction plants, subject to the terms and conditions of the contract.

3. Describe affiliation with LNG Liquefaction Export Facility (e.g., owner, capacity holder, etc):

The contract was entered into by Cheniere Marketing, LLC, which is an affiliate of Sabine Pass Liquefaction, LLC (the owner of the Sabine Pass LNG Terminal).

4. Exact Legal Name of Parties/Counterparties to Contract:

Seller: Cheniere Marketing, LLC
Buyer: Sinochem Group Co., Ltd

5. a. Contract Type (e.g. Purchase and Sale Agreement; Liquefaction Tolling Agreement, etc.):

6. Date of the Contract:

November 4, 2021

7. Contract Term:

Pursuant to the terms of the contract, a supply period of approximately seventeen and a half (17.5) years, beginning in 2022.

8. Annual Quantity:

An initial amount equal to approximately 47,000,000 MMBtus per full calendar year which increases to approximately 94,000,000 MMBtus per full contract year, subject to the terms and conditions of the contract.

9. Take or Pay (or equivalent) Provisions/Conditions:

Pursuant to the terms of the contract, during any contract year, the Seller is obliged to make available to Buyer the scheduled cargo quantity, or compensate Buyer if not made available, unless otherwise excused under the contract. Similarly, during any contract year, the Buyer is obliged to take and pay for the scheduled cargo quantity, or compensate the Seller if not taken, unless otherwise excused under the contract.

10. Supplier (title holder) of Natural Gas to Liquefaction Facility (include whether long or short-term supply, or both), if appropriate:

11. Legal Name of Entity(ies) that has(have) Title to the Natural Gas and LNG through the LNG Facility until Export (at the Flange of the Vessel):

Sabine Pass Liquefaction, LLC or other entity (as applicable, depending upon delivery point)

12. Export Destination Restrictions in the Contract:

The contract restricts resale or transfer of LNG received by the Buyer under the contract to destination countries permitted under (i) the applicable DOE/FE export authorizations and (ii) U.S. law.

13. Resale Provisions:

The contract provides for the parties to agree to comply with the applicable export authorizations, including incorporating into any resale contract for LNG sold under the contract the necessary conditions to ensure compliance with the applicable export authorizations.
