Long-Term Supply Contract**

Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC (“Sabine Pass”) hereby notifies the Department of Energy, Office of Fossil Energy (“DOE/FE”) of an assignment of a previously submitted long-term contract associated with the long-term supply of natural gas to the Sabine Pass LNG facilities in southwest Cameron Parish, Louisiana. Sabine Pass has been notified of a merger between Montage Resources Corporation (“Montage”) and Southwestern Energy Company (“SWN”) as of November 13, 2020, with SWN being the surviving entity. As a result of the merger, SWN became a party to the NAESB Base Contract for Sale and Purchase of Natural Gas dated December 20, 2017 (“Base Contract”) between SPL and Montage, as successor-in-interest to Eclipse Resources Marketing LP, and the related Transaction Confirmation dated May 24, 2017 (“Confirmation”). SWN subsequently assigned the Confirmation to its affiliate, SWN Energy Services Company, LLC (“SES”), formerly known as Southwestern Energy Services Company, effective as of December 1, 2020.

Upon effectiveness of the assignment, the Confirmation became governed by the NAESB Base Contract for Sale and Purchase of Natural Gas dated November 1, 2013 between SPL and SES.

Sabine Pass hereby submits<sup>1</sup> for filing under seal, a non-redacted copy of the Base Contract and the Confirmation. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy Order Nos. 2833, 2961-A, 3306, as amended by 3306-A, 3307, as amended by 3307-A, 3384, as amended by 3384-A, 3595, 3669, as amended by 3669-B, 3792 & 4520.<sup>2</sup> Sabine Pass hereby requests confidential treatment of the Base Contract and
