Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the Gas Supply Agreement entered into by Sabine Pass on January 19, 2023 (the "Contract") with Paloma Natural Gas, LLC ("Counterparty"). Under the Contract, Counterparty will sell and Sabine Pass will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.
