Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the NAESB Base Contract for Sale and Purchase of Natural Gas (as may have been amended from time to time, the "Base Contract") and the Transaction Confirmation ("Confirmation"), entered into by Sabine Pass on February 25, 2014 and May 19, 2021 (respectively) with Equinor Natural Gas LLC formerly known as Statoil Natural Gas LLC ("Counterparty"). Under the Base Contract and Confirmation, Counterparty will sell and Sabine Pass will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.

Sabine Pass is also filing herewith a public summary of the major provisions of the Base Contract and Confirmation. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy ("DOE/FE") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792 and 4520 (each as may have been amended).² Sabine Pass hereby requests

Pursuant to the terms of the contract, in respect of any day, the Seller is obliged to deliver to Buyer a specified quantity of gas, or compensate the Buyer if not made available, unless otherwise excused under the contract. Similarly, in respect of any day, the Buyer is obliged to take a specified quantity of gas, or compensate the Seller if not taken, unless otherwise excused under the contract.
