

Proposed Action Title: 735-A Nonproliferation Technologies Section Inorganic Mass Spectrometry Laboratories

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Since 1999, the Nonproliferation Technologies Section (NTS) has established and maintained inorganic mass spectrometry laboratories for the analyses of environmental samples to detect extremely low levels of anthropogenic radionuclides in liquids and solids.

 $\square$  The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

 $\square$  The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
