

Proposed Action Title: SRS Barricade 9 Replacement Project

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The US Army Corps of Engineers (USACE) will subcontract the final design and construction of Barricade 9 Entry Control Facility (ECF) replacement. The USACE will oversee the construction of the upgraded ECF. SRNS will perform onsite project management services and will be responsible for the installation of fiber (FedNet), construction of a new domestic water well and septic system, electrical upgrades, and environmental compliance oversight.
