Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Makai Ocean Engineering, Inc. to design, develop, and fabricate a High Temperature High Pressure (HTHP) heat exchanger plate for the purposes of meeting DOE SunShot Initiative cost targets for concentrating solar power (CSP) technologies.

Activities associated with the proposed project would be limited to data analysis, computer modeling, preliminary engineering/design, and bench-scale laboratory research and development (R&D). Prototype plates would be designed, developed, and fabricated at the Recipient's Ocean Energy Research Center located at the Natural Energy Laboratory of Hawaii Authority in Kailua Kona, HI. HTHP testing of fabricated test units would be conducted by Sandia National Laboratories in Albuquerque, NM.

The proposed project would not involve the use or handling of hazardous materials. In-lab activities involving laser fabrication and HTHP testing would be conducted following existing corporate health and safety policies and procedures, including employee training and the use of proper personal protective equipment. At the conclusion of the proposed project, materials and equipment procured or fabricated by the proposed project would be retained for future research.

All project activities would occur indoors at existing, dedicated R&D facilities; therefore, no modifications or new permits and/or authorizations would be necessary. No change in the use, mission, or operation of existing facilities would arise out of this effort. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project. Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.
