Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B5.1 Actions to conserve energy or water

(a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the Navajo Tribal Utility Authority (NTUA) to bring renewable off-grid power to remote homesites in the Navajo Nation that are not currently connected to any electrical grid. By installing ground-mounted solar photovoltaic (PV) units, the proposed project would generate clean energy while bringing long-needed access to reliable electricity that was hitherto much too expensive to connect via the regional utility.

All administrative project activities would be conducted by NTUA at their headquarters in Fort Defiance, Arizona. Forty

(40) homes in New Mexico on the Navajo Nation Reservation have been identified for the proposed installations based on their remoteness and location that makes grid-connected electricity prohibitively expensive for residents. NTUA, which is the Navajo Nation's multi-utility provider of service in this region, would contribute workforce experience and labor to facilitate the procurement, installation, and maintenance of the PV units at these sites.

The residences would be fitted with a combination of commercially available equipment:

- Ground-mounted PV array (10 solar panels) with hybrid inverter
- · Battery storage
- · An energy efficient refrigerator
- A generator
- · House wiring, if needed.

Depending on the size and orientation of each site, it is anticipated that approximately 3.0 kW off-grid PV units would be installed. The panels would be mounted on a steel skid adjacent to the existing residence. Installation of the skid-based array would result in minor ground disturbance; all equipment would rest on the surface of land that has been previously disturbed due to original building construction and habitation. For the proposed solar systems, NTUA is not required to obtain rights-of-way from the Navajo Nation because the installations would be located at residential premises. No additional permits, licenses, or authorizations would be required to perform project activities.

The proposed project would involve electric utility work. Standard industrial health and safety procedures would be in place to mitigate potential hazards to project workers.

Based on the types of activities proposed to be conducted by a tribal-government utility agency at preexisting homesites on reservation lands for tribal benefit, DOE does not anticipate any impacts to resources of concern due to the proposed project. Any work conducted on tribal lands or tribal properties may be subject to additional review by the cognizant Navajo Nation official and NTUA would adhere to applicable polices for inadvertent cultural resource discoveries.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
