Proposed Action Title: University of Central Florida -- Model-Based Systems Engineering and Control Co-Design of Floating Offshore Wind Turbines

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's information gathering and analysis efforts to develop a comprehensive modeling and simulation platform for floating offshore wind turbines. Phase II of this project under the Aerodynamic Turbines Lighter and Afloat with Nautical Technologies and Integrated Servo-control (ATLANTIS) Program will continue improving and refining the software platform, and integrating multiple turbine designs for analysis in the software. If successful, the software will reduce time, cost, and risk associated with offshore wind turbine engineering and testing design iterations, leading to faster introduction of product to market to produce low-emission energy.

The proposed project activities under this award are limited exclusively to intellectual, academic, or analytical activities. The project team will not conduct physical experiments, prototype fabrication, demonstration projects, or similar activities under this award.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
