Proposed Action or Project Description:

LM proposes to perform routine site inspections, maintenance, and monitoring activities at the Ambrosia Lake, New Mexico, Disposal Site as required by the site's Long-Term Surveillance Plan and Groundwater Compliance Action Plan.

Inspections, site visits, and site tours would be performed to inspect the site and its features and assets noninvasively and visually for informational gathering or sharing purposes. At a minimum, the site would be inspected annually.

Routine maintenance and monitoring activities would include the following: maintenance on signs, monuments, and survey markers; fence and gate repair and replacement; vegetation management, monitoring, and pollinator studies; maintenance of monitoring wells and pads; minor road repairs; trash removal; groundwater monitoring and sampling; land surveying; and other nonground-intrusive monitoring. A System Operation and Analysis at Remote Sites (SOARS) station and associated instrumentation and equipment would be installed, operated, inspected, calibrated, maintained, repaired, modified, upgraded, replaced, or removed, as necessary.
