SUBJECT: Notice of Scoping for the TerraPower, LLC's Test and Fill Facility Project, Lincoln County, WY (DOE/EA-2217)

The U. S. Department of Energy (DOE) is requesting public input on the scope of an Environmental Assessment (EA) for TerraPower, LLC's (TerraPower) Test and Fill Facility (TFF) Project, located in Lincoln County, Wyoming. DOE is proposing to authorize the expenditure of federal funding by TerraPower to support the construction and operation of the TFF. The TFF would receive, sample, process, store, and deliver liquid sodium to areas where component tests are performed as well as the planned Kemmerer Unit 1. The research from the TFF would serve the sodium reactor community at large as the technology continues to grow and be adopted around the world. DOE will be the lead federal agency in the preparation of the EA.

Pursuant to the requirements of the National Environmental Policy Act (42 U.S.C. 4321 et seq.; NEPA), Council on Environmental Quality regulations (40 CFR Parts 1500 to 1508), and DOE NEPA implementing procedures (10 CFR Part 1021), DOE, is preparing a draft EA to evaluate the potential direct, indirect, and cumulative impacts of the proposed project.

Resource Areas that Will be Considered in the EA

The EA will describe and analyze potential impacts to the human environment that would be caused by the proposed project and, as applicable, will identify possible mitigation measures to reduce or eliminate those impacts. DOE has identified the following resource areas and issues for consideration in the EA:

- Biological Resources
- Socioeconomics
- Environmental Justice
- Cultural and Historic Resources
- Geology and Soils
- Hydrology
- Infrastructure including emergency services, transportation, and traffic
- Accidents including destructive acts

Public Scoping
