

Proposed Action Title: Research on Invasive Mammals

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This is a collaborative study with USFS and University of Wisconsin. This research will allow USFS to better understand the relative ecological effects of two invasive mammals: wild pigs and coyotes. This will allow us to evaluate their impacts on Savannah River Site.
