

Proposed Action Title: Post Installation and Rigging Pulley Installation at L3R1-A

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

A more suitable location to gauge field parameters at station L3R1-A was identified. The following activities will take place to establish the new location for sampling: Site Infrastructure will install two posts across stream at the L3R1-A gaging station. The area will be mowed for access. Site Rigging will install a pulley system across stream.
