Rationale for determination:	
The U.S. Departmen	t of Energy (DOE) is proposing to provide funding to BREK Electronics Corp for the development

The U.S. Department of Energy (DOE) is proposing to provide funding to BREK Electronics Corp for the development of a solar inverter with a battery storage interface. Project activities would include the design, fabrication, and testing of a 72 kW solar inverter prototype.

Design, fabrication, and testing of power electronics hardware and software for the inverter prototype would occur at the electronics laboratory at BREK headquarters in Broomfield, CO. Assembly and testing of the prototypes would occur at Premier Manufacturing, a manufacturing and industrial park in Frederick, CO. Approximately 10 inverter prototypes would be fabricated.

All project activities would be completed in existing, purpose-built facilities. No new permits or licenses would be needed to perform award activities. Potential hazards include the presence of high voltages, up to 480 volts AC and 1000 volts DC, during laboratory testing. Existing corporate health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate adverse impacts on these resources.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
