

Proposed Action Title: University of California, Irvine -- MacroAlgal Cultivation MODeling System (MACMODS)

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

SECOND AMENDED NEPA DETERMINATION: (See attached original Determination, dated January 19, 2018 and First Amended Determination dated January 18, 2022). This Second Amended Determination follows the approval of additional funds and extended period of performance to support the project team's small-scale, research and development activities to continue testing, validating, and expanding prototype-scale offshore macroalgae cultivation. Specifically, the project team will (1) optimize farm design; (2) develop a tracking model for managing invasive species; and (3) collect data from a commercial kelp farm. If successful, the project team will develop a proven system for large-scale macroalgae farms for use in producing biofuels.

Project activities will be conducted at existing facilities at University of CA, Irvine (Irvine, CA), University of CA, Los Angeles (Los Angeles, CA), University of CA, San Diego (San Diego, CA), Southern CA Coastal Water Research Project (SCCWRP) (Costa Mesa, CA), and Ocean Rainforest Pilot Farm Site (Santa Barbara, CA) designed for the proposed work. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

AMENDED NEPA DETERMINATION: (See attached original Determination, dated January 19, 2018)

This Amended Determination follows the approval of additional funds to support the project team's small-scale, research and development activities to improve macroalgae cultivation design in terms of optimized plant growth and environmental sustainability. Specifically, the project team will (1) collect additional data to validate the team's "MACMODS" design tool for multiple species of macroalgae; (2) develop a methodology to represent the fine-scale physics captured in large-eddy simulations into a regional model; and (3) conduct outreach to relevant communities regarding the findings and tools developed. If successful, the team will have created a computational framework to design and deploy macroalgae farms, a first for the industry.

Project activities will be conducted at existing facilities designed for the applicable activities (at UC Irvine, UC Los Angeles, UC Santa Cruz and the Southern California Coastal Water Research Project) and at pilot farm sites including the Ocean Rainforest pilot farm (Santa Barbara, CA). Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Proposed Action Description:

The MARINER Program seeks to fund the development of technologies to enable the United States to become a leading producer of macroalgae, or seaweed, for use as a biofuel to improve U.S. energy security and economic competitiveness. The MARINER Program is composed of 18 small-scale research and development projects that will be conducted by universities, non-profit entities, for-profit entities, and federal laboratories. All 18 of the MARINER projects (listed in Attachment A) are covered by this Determination and fit within the class of actions identified under the DOE Categorical Exclusions identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. Project tasks for these 18 projects under the MARINER Program will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements. If successful, MARINER technologies could help the US produce at least 500 million dry metric tons of macroalgae per year. Such volumes could yield 2.7 quadrillion BTUs of energy in the form of liquid fuel, 10% of the nation's annual transportation energy demand. Prime Recipients for 6 of the 18 MARINER projects have not obtained all necessary permits and approvals applicable to proposed actions in accordance with local, state, and federal requirements. All 6 Prime Recipients, under the terms of their cooperative agreements, are prohibited from commencing applicable project work before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same
