Rationale for determination:

[The U.S. Department of Energy \(DOE\) is proposing to authorize the administration of a four-phase prize competition, known as the "National Building Upgrade Prize". The prize would provide cash and technical assistance toward the development of innovative program models to accelerate building upgrades. Additional funds may be awarded to select recipients focused on delivering scalable and replicable building upgrades to disadvantaged communities, low-and-moderate income \(LMI\) households, and disadvantaged businesses.](#)

[DOE previously completed one NEPA Determination \(ND\) \(GFO-National Building Upgrade Prize-001; A9; 11/23/2022\) for this prize. That ND covered the development of concept plans \(phase 1s and 1\). This ND reviews phase 2 of the prize. Future phases of the prize would be dependent on the outcome of phase 2 and would require additional NEPA review.](#)

[Phase 2 of the prize competition would support phase 1 prize awardees with the further development of their concept plans into implementation plans. This phase would include the development of implementation plans, plan submission, review, and selection for the next phase of the prize.](#)

[Prize competition activities of any applicant selected within phase 2 would include only intellectual, academic, or analytical activities such as administrative and educational activities. Based on the types of activities anticipated to occur as part phase 2 of the prize competition, DOE does not anticipate any impacts to resources of concern.](#)

FOR CATEGORICAL EXCLUSION DETERMINATIONS

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
