Description:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Regents of the University of California, San Diego (UCSD) to design, develop, fabricate, and test polymer interlayers for insertion into photovoltaic solar cells to facilitate their recycling.

The scope of the proposed project would be limited to indoor, bench-scale research and development. All project activities would be conducted at UCSD laboratories (La Jolla, CA) that were purpose-built for the types of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort. The recipient has all applicable permits in place and would not need additional permits for the proposed activities.

The proposed project would involve the use and handling of various hazardous materials, including toxic metals and organic solvents. All such materials would be managed in accordance with federal, state, and local environmental regulations. Existing university health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
