Proposed Action Title: North Carolina State University -- High-density Sintered Silicon Carbide (SSiC) 3D-printed Lattices for Compact High-temperature High-pressure (HTHP) Aero-engine Recuperators

Proposed Action Description:

Funding will support the project team's small-scale research and development of a 3D-printed ceramic heat exchanger (HX) for aero gas-turbine engines. Specifically, the project team will focus on expediting the drying time of the 3D-printed ceramic using three methods to determine the most effective and durable method to apply for widespread application and use. If successful, the project would deliver high quality, durable HX modules with cost-effective production, using less water for cooling and eliminating thousands of tons of CO<sub>2</sub> emissions.

Project activities will be conducted at existing facilities at North Carolina State University (Raleigh, NC) and Robocasting Enterprises (Albuquerque, NM). Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusions identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
