

Proposed Action Title: General Building Maintenance Activities in the SRPPF (aka MOX) Complex Area facilities

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers various routine maintenance activities that occur in and around the buildings within the SRPPF Complex Area.

Revision 1 added Buildings 226-F and 717-34F to the list of buildings.

Revision 2 added Building 211-44F, extended the coverage dates, and added additional maintenance activities.

Revision 3 changed the area name from MOX Complex to SRPPF Complex, expanded activities to include roof repair, and extended the coverage date.

Revision 4 added Building 706-7F.

Revision 5 added four warehouses (731-2F, 221-12F, 221-21F, and 221-22F) and extended the coverage date.

Revision 6 added two additional buildings (246-3F and 284-10F), added additional maintenance activities, and extended coverage date.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

 \checkmark The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
