Proposed Action Title: Design of New Terminal Engineering and Manufacturing High Pressure Diffuser Assembly Stages in HANM DI (M-DCP-H-23008)

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The currently installed high pressure diffuser stages in HANM DI (Diffuser) are manufactured by Johnson Matthey (JMI). This vendor is no longer in business of manufacturing diffusers and therefore, a new vendor, Terminal Engineering and Manufacturing (TEM), was selected to design an almost like-for-like diffuser to replace the old JMIs diffusers during failure. The designs are almost like for like; however, there are slight difference between the two designs. Installation and process assembly will differ for the TEM diffuser stages due to sizing as well as operational difference (i.e. heater elements and thermocouple connections). The HANM diffuser stage will be replaced per DCP, upon failure or when the system engineer deems immediate predictive maintenance necessary to the life of the system.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
