Proposed Action Title: Precipitation, Calcination, Dissolution of Metal Oxides and Nitrates in Organic and Aqueous Solutions

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This activity will investigate the dissolution rate kinetics of metal oxides, with a particular focus on lanthanide oxides, in an organic solutions such as tributylphosphate (TBP) in a straight carbon chain diluent like dodecane.

Revision 1: This study will also include dissolution rate kinetics of metal oxides and nitrates in acidic solutions, along with metal nitrates in organic solutions

Revision 2: This study will also include study the dissolution of actinides as oxides or nitrates in organic and aqueous solutions. The actinide oxides or nitrates will be prepared by co-precipitation and calcination (potentially after being purified)

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
