

Proposed Action Title: CM 4211 Install Promabeam saw from laydown yard to 711-N

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

CM 4211 Install Promabeam saw from laydown yard to 711-N. Work group to remove existing roller tables, and anchors on west side of 711-N Iron Workers side, install/anchor taller roller tables that work with Promabeam saw loading height, reinstall/anchor Promabeam saw in its previous location, and reconnect saw to power source.
