Proposed Action Title: University of Notre Dame -- GaN Core-shell Nanofin Vertical Transistor (CoNVerT): A New Direction for Power Electronics

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Boulder, Colorado; Notre Dame, Indiana

Proposed Action Description:

Funding will support the project team's small-scale research and development of a low-cost power transistor design that leverages the properties of the semiconductor gallium nitride for mid-range voltage applications such as electric vehicles, renewable energy grid integration, industrial power control, and grid resilience. Specifically, the project team will (1) design, simulate, fabricate, characterize and analyze a transistor device, and (2) develop nanofin material for use in transistor operation. If successful, this project could result in energy savings of one quadrillion British Thermal Units (BTU) per year, roughly equivalent to 1% of annual energy consumption in the U.S.

Project activities will be conducted at existing facilities at University of Notre Dame (Notre Dame, IN) and National Institute of Standards and Technology (Boulder, CO). Project tasks fit within the class of actions identified under the DOE Categorical Exclusion identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
