Proposed Action Title: Marathon Fusion, Inc. -- Advanced Metal Foil Pumps and Integrated Test Environment for the Fusion Fuel Cycle

Program or Field Office: Advanced Research Projects Agency - Energy

## **Proposed Action Description:**

Funding will support the project's small-scale research and development of a test stand to support the evaluation and advancement of metal foil pumps used in nuclear fusion systems. Specifically, the project team will (1) build an integrated metal foil pump test stand; (2) test and verify the stand design; (3) assess a metal foil pump assembly using the project test stand; and (4) adjust or correct the test stand if necessary. If successful, this project would result in a testing system for metal foil pumps for fusion pilot plants on the decadal timescale, thereby advancing the potential commercialization of fusion energy.

Project activities will be conducted at an existing facility at Marathon Fusion, Inc. (San Francisco, CA). Project tasks fit within the class of actions identified under the DOE Categorical Exclusion identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
