Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer congressionally directed spending to the Vermont Energy Investment Corporation (VEIC) to test the effectiveness of water to phase change materials (PCMs; salt hydrates or bio-based wax) as thermal energy storage (TES) materials. The award aims to achieve this by replacing the existing fossil fuel heating systems with electric heating systems at four separate locations in Vermont and monitoring the performance levels of each system.

This NEPA Determination (ND) does not apply to Task 5 through Task 11 activities. DOE will complete the NEPA review for Tasks 5 through 11 when sufficient information is available to conduct a meaningful review. Sufficient information includes completed design of the electric heating system with either water storage or a PCM medium (i.e., TES systems) at each location proposed along with specifics on all other associated award activities. Additionally, only two out of the four potential locations are currently known. DOE requires that all potential locations be defined before conducting another NEPA review. It is anticipated that by completing Task 1 through Task 4 activities, VEIC will have selected all locations and completed design plans for each location.

Award activities associated with Tasks 1 through 4 include outreach, data analysis, technical assistance, site surveying of existing fossil fuel heating systems, and preliminary engineering/design. Task 1 activities would involve the investigation, recruitment, and enrollment of testing locations. Task 2 and Task 3 activities would focus on drafting the TES system designs and completion of construction drawings and documents, respectively. Construction-level bids for TES integration and electric services upgrades would comprise Task 4 activities.

VEIC (Winooski, VT) and Norwich University (Northfield, VT) would perform data analysis activities. Dubois & King, Inc. (South Burlington, VT) would be responsible for engineering and design activities. Both Westminster Armory (Westminster, VT) and Berlin Armory (Berlin, VT) are the two known potential locations where TES systems are proposed. However, per this ND, only site surveying of the existing fossil fuel heating systems would occur at these locations. This type of site surveying activity would also occur at other potential locations proposed for TES system installations. Construction or ground disturbance of any kind are not covered by this ND. All facilities are preexisting and purpose-built for the type of work to be conducted for Tasks 1 through 4. Facility modifications would not be required.

Please note that Section 106 consultation with the Vermont State Historic Preservation Office (SHPO) may be required if the locations associated with the proposed TES system installations are 50 years or older. The finalized locations, completed designs, and details on associated award activities at each location are to be submitted for further NEPA review prior to starting Task 5. Construction cannot begin until DOE has (1) received the required information (2) performed another NEPA review and (3) obtained SHPO concurrence, if applicable.

DOE has considered the scale, duration, and nature of proposed activities associated with this ND to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

A portion of the proposed action is categorically excluded from further NEPA review. The NEPA Provision identifies Topic Areas, Budget Periods, tasks, and/or subtasks that are subject to additional NEPA review.
