Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Colorado Boulder (CU) to design, produce, and test perovskites (i.e., a type of material used in some solar energy technologies) for hydrogen fuel production applications. Award activities would include those of an intellectual, academic, and analytical nature, including computer modeling, data analysis, and document preparation. Modeling activities would inform the selection of at least three different perovskites powders which would be produced, characterized, and tested in laboratory settings. Several hundred grams of chemical compounds (e.g., salts) would be used to produce perovskite powders.

Activities would be completed by CU (Boulder, CO), Argonne National Laboratory (ANL) (Lemont, IL), Brookhaven National Laboratory (Upton, NY), Colorado School of Mines (Golden, CO) and the University of South Carolina (Columbia, SC). All facilities are preexisting purpose-built facilities for the type of work to be conducted for this award. Facility modifications would not be required. Award activities would involve typical hazards associated with nanomaterials and laboratory operations, including handling and use of hazardous materials and operation of potentially hazardous equipment. Existing health, safety, and environmental policies and procedures would be followed to mitigate hazards to acceptable levels. Mitigated hazards would pose negligible risks to the public and environment. All activities would comply with existing federal, state, and local laws and regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders. A diversity, equity, and inclusion (DEI) plan would be implemented to encourage the inclusion of individuals from underrepresented groups in fields of science, technology, engineering, and mathematics (STEM).

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
