Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Yakama Nation Housing Authority to install roof-mounted solar photovoltaic (PV) panel arrays on 46 newly build homes on the Yakama Nation Reservation in Wishram Heights, Washington. Additionally, tribal members will be trained on solar PV installation, operation, and maintenance processes.

Award activities include design work, procurement, installation, testing, and commissioning the solar PV systems as well as training at least six tribal members in the operation and maintenance of the systems. Each of the 46 newly built houses will receive a roof-top solar PV system (approximately 4.74 KW) that will tie into the Klickitat PUD community electrical grid. Connections to the grid would occur through the existing home electric connections. No ground disturbance would occur.

Minimal air emissions would occur during installation from the use of small-scale construction equipment and vehicles. Significant air impacts are not anticipated as construction equipment and vehicle use would be temporary and intermittent. Project activities would involve hazards associated with routine installation activities and working with electricity. Any risks working with hazards would be mitigated through established Tribal and government safety and construction protocols. The Yakama Nation Housing Authority to would observe all applicable health, safety, and environmental regulations. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
