Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer congressionally directed spending to the City of Las Cruces, New Mexico (City) for the construction of solar powered parking shade structures at the Mesilla Valley Community of Hope campus. The installations would generate 185,000 kilowatt hours of solar power to offset energy costs for agencies that provide services to homeless populations in the southern New Mexico region.

The City would solicit bids from qualified contractors for the design and construction of two solar carport structures. The designated sites are located on previously developed land used as parking areas for employees and agency vehicles/vans. The installations would consist of an estimated total of 250 solar panels and the necessary steel framing to elevate them above the current parking areas. Minor ground disturbance to install supports for the shade structures would be necessary. Building and electrical permits would be required through the State Building Department and the proposed project would be inspected by the New Mexico Construction Industries Division for Code Compliance.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
