Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to T2M Global, LLC (T2M) to design, develop, and test a Waste Heat to Osmotic Power (WHOP) engine in order to recover and utilize low-level waste heat emitted during electricity production.

Award activities would focus primarily on outreach, data analysis, modeling, engineering and design, and laboratory scale research. The types of activities associated with the awards would include membrane development, nanocomposite additive development, polymer formulations, WHOP fabrication, assessment of water-soluble organic compounds, and laboratory scale testing of membranes and the WHOP engine. Lastly, techno-economic assessments, life cycle analyses, and commercialization strategy planning would be carried out.

T2M (Brookfield, CT) would analyze results of the WHOP development, as well as contribute to its design. Trevi Systems, Inc. (Rohnert Park, CA) would carry out development, fabrication, assembly, and testing of the WHOP components and system, as well as other laboratory testing. Tim Lipman (Berkeley, CA) would perform computer modeling of the WHOP system. CFASE (Wilmington, CA) would perform outreach to disadvantaged communities (DACs), including identifying suitable DACs and sites suitable within DACs for future demonstrations.

Award work would be performed at pre-existing facilities that are purpose-built to accommodate the type of laboratory work and testing to be conducted for this award.

Award activities would involve handling and use of hazardous materials, including polymers, green solvents, and green draw solution. Environmental Health and Safety policies and procedures would be followed, as well as all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

DOE has made a final NEPA determination.
