Proposed Action Title: Deep Isolation -- Sequential Advancement of Technology for Deep Borehole Disposal (SAVANT)

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Santa Clara, California; Atlanta, GA; Houston and Cameron, Texas; Charlotte, North Carolina;

Proposed Action Description:

Funding will support the project team's small-scale research and development of a universal canister design for spent nuclear fuel. The project team will also assess the capabilities of potential US-based suppliers of such a canister. Specifically, the project team will (1) enhance a model of canister design, (2) lab test and verify design features, (3) pilot test canister function and viability, (4) conduct pilot-scale, borehole field testing of canister, and (5) conduct post-test examinations of canister function and viability. If successful, this project would produce a safe, scalable, and cost-effective disposal method for spent nuclear fuel, advancing low-emission nuclear energy production.

Project activities will be conducted at existing facilities at Deep Isolation U.S. LLC (Santa Clara, CA and Atlanta, GA), SLB (Houston, TX), Electric Power Research Institute (Charlotte, NC) and Deep Borehole Demonstration Center, Cameron Test Facility (Cameron, TX). Project tasks fit within the class of actions identified under the DOE Categorical Exclusions identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. The project team has certified they possess all necessary permits, authorizations and approvals to conduct the applicable project work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
